EXTRA CHARGES

Mileage Charge*	\$2.00/kilometer/vehicle
Concrete Anchors**	As per trucking quote

*Mileage charge only applicable on rentals outside Fort McMurray city limits.

**Renter will be provided with a written quote from trucking company for the cost of delivering concrete anchors. We do not charge a rental fee for the concrete anchors—only the cost to get them to and from your event location. Anchors are mandatory for tents when erected on a surface that does not allow stakes to be driven.

NOTE: interPLAY will strive to accommodate rental requests made with a minimum two weeks notice. Rental requests will be accepted or rejected at the discretion of the interPLAY Tent Manager.

NEW POLICY: The Fort McMurray interPLAY Society has a new policy which states that these tents will only be available between April 1 – September 20. The tents will not be available during the winter months.



Renter is responsible for:

- Providing sufficient and sober manpower to enable the safe erection and dismantling of the tent(s).
- Obtaining any licenses and permits required by Federal, Provincial and Municipal authorities.
- Arranging for any necessary locates for underground services.
- Maintaining or obtaining sufficient insurance coverage as described in the rental contract.
- Paying a deposit of \$250 in order to secure booking, of which, \$50 is a non-refundable booking fee. For additional tents on the same booking we require an additional deposit of \$200 per tent. The booking fee is applied to your final bill as a credit. The remainder of your deposit will be returned to you within 10 business days of the conclusion of your rental and complete rental payment. Deposits are required at the time of booking by cash or cheque.
- Renters canceling their booking within 14 days of their rental will forfeit their entire deposit.

interPLAY Tent Manager is responsible for:

- Providing renter with an accurate quote, based on specific requirements.
- Providing a qualified person to supervise the safe erection and dismantling of the tent(s).
- Delivery of tent(s) to and from the rental location.
- Visiting rental location every 48 hours to ensure safety of tents during long-term rental contracts.
